Study Purpose: The purpose of this study is to examine the change mechanisms of an integrated care model adapted for patients with Type 1 diabetes. In addition, the study will utilize implementation science methods to analyze the acceptability, fidelity, and potential scalability of the care model in primary care settings. Findings from this study will provide information regarding the active ingredients of the integrated care model and how these impact patient outcomes while identifying methods to enhance patient and provider acceptability.

Addressing Depression through Solution-Focused Brief Therapy in Integrated Care Settings

Study Purpose: The purpose of this study was to examine the efficacy of a Solution-Focused Brief Therapy (SFBT) intervention for patients with co-occurring depressive symptoms. In addition, the study utilized innovative implementation methods to assess intervention fidelity and acceptability. Patients were randomized to either treatment as usual or to receive the SFBT intervention. Then, I compared outcomes regarding depression, anxiety, well-being, and healthcare outcomes (i.e., blood pressure, hemoglobin A1C, weight change).

Study Purpose: The purpose of this study is to adapt a Solution-Focused Brief Therapy Intervention to address co-occurring diabetes and depression. In addition, this study leverages innovative quantitative methods to examine change mechanisms, including self-esteem, motivation, and self-management, assessing their indirect effect on glycemic control and depressive symptoms. Pilot data from a previous trial have demonstrated the short-term efficacy of this approach, and this proposal examines these effects over a longer period (6 months).
